INTRODUCTION

PERSONAL INFORMATION WE COLLECT

Information you give the family:

- ❖ Customer Support Details: When you reach out to the Cartel's support team, we may collect your name, email, and any other details you offer to help us resolve your concerns. This info stays between us - it's used solely to assist you.
- ❖ Opt-In Communications: If you choose to sign up for updates, newsletters, or the Don's briefings, we'll collect contact details (like your name and email) to keep you in the loop.
- ❖ Accuracy of Your Info: The Don expects loyalty and honesty. Make sure the personal information you provide is accurate and up to date, it keeps the operation running smoothly.

Information the family collects automatically:

- ❖ Identifiers: We may collect your IP address, device info, browser type, operating system, and how you interact with the Territory.
- ❖ Cookies: We use cookies and other tools (pixel tags, web beacons) as our lookouts, helping us recognize your device and improve your experience. Manage your cookie preferences anytime but disabling them might affect some of the operations. Check the Cookie Policy for the full rundown.
- ❖ Usage data: We collect intel about how you navigate the Territory - your moves, your clicks, and how long you hang around.

Information from trusted allies:

- ❖ **Third-party platforms:** If you connect through platforms like Metamask, Google, or others, we may receive details like user IDs or token balances.
- ❖ **Blockchain transactions:** All blockchain dealings (purchases, transfers, and so on) are recorded on public ledgers. We don't touch private wallet info, but we monitor the streets (through blockchain explorers) to keep an eye on transaction data.
- ❖ **Analytic services:** The Don relies on tools like Google Analytics to understand traffic patterns and refine the Territory. This info doesn't identify you personally - it's all about the bigger picture.

HOW THE CARTEL USES YOUR INFORMATION

We handle your info with care and purpose. Here's what we do:

- ❖ **Providing Services:** To deliver what you've requested - transactions, responses, and all the perks of the Cartel's operation.
- ❖ **Improving the Territory:** Knowing how you interact helps us refine the experience and make everything run smoother.
